<u>GRANTS</u>

Do not have to be repaid; "gift aid"

SCHOLARSHIPS

Do not have to be repaid, based on varying criteria

LOANS

Can be Federal or private, must be repaid with interest

Must have graduated from a Nevada high school

Must complete high school with a 3.25 cumulative GPA or 21+ ACT or 1070+ SAT

Must have the following core units:

Social Science	3

Will pay up to \$1200/semester for classes over 100 level at University

Will pay up to \$900/semester for classes over 100 level at Nevada State College

Will pay up to \$600/semester at a Community College

Renewable with a 2.75 GPA.

No FAFSA is required

Millennium Scholarship Cont.

- High school will send student information to Nevada Treasurer's Office
- Letters to recipients are mailed in late July/early August
- Need to complete the Acknowledgement of Award
- \$80 per credit up to 15 credits per semester at university or \$60 per credit up to 15 credits at Nevada State College or \$40 per credit at community college
- Does not pay for remedial courses

Your FSA ID is used to sign legally binding documents electronically. It has the same legal status as a written signature. **Don't give your FSA ID to anyone or allow anyone to create an FSA ID for you—not even your parent, your child, or someone helping you fill out the FAFSA® form**. Sharing your FSA ID is like teaching someone to forge your signature; and it could put you at risk of <u>identity theft</u>!

What you should do next

Review your SAR. Your SAR is a summary of the information you provided on your FAFSA form; **it is not your financial aid offer.** Log in to **fafsa.gov** with your FSA ID to review your SAR.

Submit additional financial aid applications/documentation to your school(s). Some states and schools require supplemental financial aid applications if you'd like to be considered for state and/or school financial aid programs. Visit the financial aid section of your school's website to determine if there is additional documentation you must provide to apply for these programs, and be sure to submit any required documentation by the stated deadline.

Apply for as many scholarships as you can. This will help you limit the amount of money you may need to borrow to pay for school. Learn how to find and apply for scholarships.

Wait for financial aid offers. You will receive a financial aid offer from each school you listed on your FAFSA form once you are accepted for admission at that school. Review your financial aid offer to determine which financial aid you'd like to accept. If you've applied to several schools, be sure to compare aid offers to see which school will be the most affordable. Each school has its own schedule for sending out financial aid offers. Contact your school's financial aid office to find out when you will receive your financial aid offer.

Note: If you need to change the information you provided on the FAFSA form (to add a school, for example), log in to your FAFSA form and select "Make FAFSA Corrections."

Award Options Based on FAFSA



- Federal Pell Grant: \$6,345/year
 - 0 EFC; amount decreases as EFC increases; based on enrollment
- Federal SEOG: \$4,000/yr
 - 0 EFC; limited funds = apply EARLY
- Federal Direct Loans: \$5,500 combined total (freshman independent can be eligible for more)
 - 2 kinds of loans:
 - Subsidized; no payment & no interest until graduation or less than half time enrollment (less than 6 credits/semester)
 - Unsubsidized; no payment until graduation or less than half time enrollment, interest begins to accrue when loan "pays"
- All students are eligible for some type of federal loan
- Federal Work Study
- Federal Parent PLUS Ioan
 - Parent Plus; approval is based on parent's credit report; payment can begin while student is enrolled; a deferment can be requested

COVID – 19 Update

- How can we make the tuition lower?
 - Fill out your FAFSA Application opens in OCTOBER.
 - **Grants** Grants are awarded to students based on financial need, as determined by FAFSA or NSC's Non-Federal Aid Application and usually do not need to be repaid.
 - Achieve Nevada
 - Work Study opportunity for eligible students to work part-time in positions across campus
 - **Loans** NOT FREE money & will need to be paid back

Western Nevada College Nevada Promise

The Nevada Promise Scholarship is a last-dollar scholarship and incorporates service learning and mentorship with academics with the goal of increasing enrollment in higher education and improving overall student achievement, by eliminating financial barriers and allowing students to place greater emphasis on their education.

- Provides coverage of tuition and other mandatory fees not met by federal or state aid for up to three years.
- No income or high school GPA requirements, and it is open to all Nevada high school students graduating between August 1 and June 15 who begin classes at WNC in the fall immediately following graduation.
- Submit application by October 31st
- Submit FAFSA by March 1st
- Students are required to enroll in a minimum of 12 credits

The SSOG, SEOG, and NV Resident awards only require FAFSA completion (no external application required to be considered).

- Submit and Complete your FAFSA file by **April 1st** for priority.
- **SSOG** (Silver State Opportunity Grant)- Requires student to be enrolled in 15 credits
- **SEOG**(Supplemental Educational Opportunity Grant)-Requires student to be enrolled in a minimum of 6 credits
- **NV Resident Award**-Requires student to be enrolled in a minimum of 6 credits
